

I. TITLE OF THE CONTEST

International Contest of Students' Scientific Works in Printing and Publishing " Youth and Printing".

II. AIM OF CONTEST

- Activization students' scientific work in higher educational establishments of printing and publishing ;
- finding gifted students for involving them in to further scientific work and taking master Degree and Postgraduate Courses ;
- Solving actual scientific tasks of the printing and publishing branch.

III. PARTICIPANTS OF THE CONTEST

- students and students' stuffs of higher educational establishments of Ukraine (printing and publishing specialities) can take part in the contest;
- students and students' stuffs of foreign countries (Poland, Slovakia, Russia, Belarus, Latvia, Lithuania, Estonia) who study the printing and publishing as well.

IV. SUBJECTS OF THE CONTEST

The contest is held in these directions:

- printing presses and automation systems machines and packing technology, technology of printing machine building ;
- automation control of technological processes and computer integrated technological processes and production in printing;
- technology of printing production, photographic and printing materials, computer and processing of textual graphic information;
- economic of industrial enterprises management, marketing, accounting and auditing in printing;
- publishing and editing,
- book business and commercial activities;
- book graphic arts and design of printing and publishing production;
- electronic multimedia editions.

V. ORGANIZATION OF THE CONTEST AND THE WAY OF ITS CONDUCT

- general guidance of the contest is accomplished by Scientific-Methodical Center of Higher Education of Ministry of Education and Science of Ukraine ;
- direct guidance of the contest is carried out by the base organization - Ukrainian Academy of Printing (UAP) which solves all the organization and methodical problems of its conduct;
- completed students' scientific works recommended by the appropriate chair and sent by the higher educational establishment where the works were done can be submitted for the contest;
- the contest is held in two rounds;
- the first round of the contest is conducted at higher educational establishments. During the first round the best scientific works are chosen for the participation in the second (main) round of the contest;
- students' scientific works chosen for the participation in the second round are sent to the base higher educational establishment;
- the estimation of the submitted students' scientific works is done by the jury of the contest;
- the jury of the contest comprises:
 - vice-rector from the scientific work - the head of the jury, deans of the faculties - members of the jury, heads of the leading chairs - members of the jury;

- the jury has the right to invite for its sessions representatives of other higher educational establishments and specialists from industrial enterprises with the vote;
- the jury charges some chairs of Ukrainian Academy of Printing or some well-known specialists to examine the works submitted for the contest;
- resolutions of the chairs and specialists are announced and approved at the jury's sessions;
- the jury makes a decision by open voting of the majority of the members having 2/3 of its members present at the given session;
- when there is an equal number of votes, the casting vote belongs to the head of the jury;
- the decision of the jury is registered in the record of proceedings;
- if the members of the jury consider that no work is worth awarding, they can limit with the confirmation of the diploma;
- as a result of work done the jury sends the records of proceedings and a brief report of work done to the Scientific-Methodical Center.

VI. PRINCIPAL CRITERIA OF WORKS ESTIMATION

- topicality of the chosen problem;
- deep analysis of the problem according to the literature studied;
- developing one's own methods, the use of the latest methods of investigation;
- completeness and entire character of the problem solution;
- availability of elements of originality and scientific novelty;
- critical interpretation of the results obtained. Quality of the conclusions made;
- prospects of introduction, assessment of real or expected economical effect;
- availability of publications, patents.

VII. TIME OF THE CONTEST CONDUCT

- the contest "Youth and Printing" is held annually;
- documents with the mark "For the contest of students' scientific works" should be sent before 18 of November every year to the following address: 79020, Ukraine, Lviv, 19 Pidholosko Street, Ukrainian Academy of Printing (Scientific-Research Department);
- the term conduct of the second (concluding) round of the contest: 18 of November - 16 of December, of the current year.

VIII. LIST OF THE DOCUMENTS SENT AND REQUIREMENTS FOR THEM

- documents for the contest are submitted in two envelopes with one and the same motto;
- the first envelope should contain:
information about the title and motto of the work, its subject direction, about the author (s) of the work and its scientific supervisor (see Addition); a justified conclusion-recommendation of the appropriate chair; two reviews of specialists (inner and external); an order of the higher educational establishment where the work was done;
- the second envelope should contain two copies of the work without marking of its author (s);
- the scientific works are done on format A4 sheets of paper in font 12 point with interval 2. The volume of the contest work should not exceed 20 pages. Drawings, illustrations for the work should correspond the page format of the work submitted and should be properly done;
- students of the Ukrainian higher educational establishments should write the text of their works in the State language and students of foreign countries - in Russian or English.

IX. REWARDING THE WINNERS

The winners of the contest can be honored with:

- diplomas of the first, second, third degrees (according to each subject direction);
- financial reward;
- diplomas of the Academy;
- publishing the marked works in Higher Certification Commission collections of the Academy;
- inviting the prize-winners to deliver a speech at annual Academy Students' scientific conference (with paying all travel, food and living expenses).
