#### **OPEN CALL FOR UNIVERSITY OF GRANADA MSCA-COFUND ATHENEA3I PROGRAMME**

We would like to inform you that the second call for MSCA-COFUND Athenea3I Programme at the University of Granada has been published.

The Universidad de Granada (UGR) announces the opening of 10 vacancies for postdoctoral studies. These vacancies are designed for excellent researchers who have experience in the fields of innovation and knowledge transfer.

These postdoctoral contracts will last for 3 years with a maximum gross salary of €4,000 per month and €1,500 in supplements depending on different factors such as the researcher's family situation, or aspects derived from the execution of the projects (required training, planned visits, etc.).

Selected researchers will join multidisciplinary teams to execute research, innovation and development projects conducted at the UGR and will therefore need a supervisor from this institution.

Moreover, researchers will be able to spend time in a different academic institution for an uninterrupted period of between 3 and 9 months, to be scheduled between the 10th and the 18th months of the research project. Researchers may spend this time in either the academic or the business sector. In addition, they may also spend a minimum of 3 months and a maximum of 6 months during the last 18 months of the research project in another non-academic institution.

Thematic fields:

- Environmental Sciences and Chemistry (ENV-CHE)
- Economics, Social Sciences and Humanities (ECO-SOC)
- Information Science and Engineering (ENG)
- Life Sciences (LIFE)
- Physics and Mathematics (PHY-MAT)

The application period lasts from **4 September 2018 to 28 September 2018**. The incorporation into the Universidad de Granada is expected to take place between July – September 2019.



➤ **Revizorji evropskega računskega sodišča o predlogu večletnega proračuna EU za obdobje po letu 2020**

V proračunu EU za obdobje 2021 do 2027, ki ga je predlagala Evropska komisija, bi bilo treba več poudarka nameniti dodani vrednosti, pravijo revizorji Evropskega računskega sodišča. Sodišče sicer odobrava večjo prožnost večletnega finančnega okvira za obvladovanje nepredvidenih dogodkov, vendar opozarja, da spremembe prioritet med področji porabe niso jasno obrazložene v predlogu ali utemeljene z objavljenimi rezultati ocene dodane vrednosti programov porabe EU, ki jo je opravila Komisija.

Revizorji opozarjajo tudi na problem časovne umestitve predloga proračuna, saj se strateški okvirji in cilji ukrepov EU prekrivajo in niso časovno usklajeni. Strategija Evropa 2020 se bo končala pred začetkom novega obdobja večletnega finančnega okvira, nov niz strateških ciljev EU pa še ni bil določen. Predlog dolgoročnega proračuna EU je v praksi postal orodje za oblikovanje političnih ciljev EU po letu 2020 in ni več samo prilagoditev nanje. To ni običajno ali logično zaporedje dogodkov, opozarjajo revizorji.

Evropsko računsko sodišče bi po mnenju Evropskega računskega sodišča moralo biti pooblaščeno za revizijo vseh organov EU, vključno z Evropsko obrambno agencijo in predlaganim Evropskim denarnim skladom, in imeti možnost, da revidira vse organe, ustanovljene zunaj pravnega reda EU zaradi izvajanja politik EU.

#### **➤ Priložnosti za vključevanje zasebnega sektorja v zunanje finančne instrumente EU**

Evropska unija je v okviru načrta EU za zunanje naložbe (EIP) napovedala finančna jamstva za projekte v Afriki in sosedstvu v vrednosti približno 800 milijonov evrov. Člani lahko podrobnejše informacije o priložnostih za sodelovanje organizacij iz Slovenije pri teh projektih dobijo na SBRA. Predstavniki Evropske komisije so možnosti za vključevanje zasebnega sektorja v zunanje finančne instrumente EU na področju energije natančneje predstavili na konferenci, ki je bila v Ljubljani 1. junija. Soorganizator te konference je bil tudi član SBRA Inštitut Jožef Stefan.

Načrt EU za zunanje naložbe je namenjen spodbujanju vključujoče rasti, ustvarjanju delovnih mest in trajnostnega razvoja, kar naj bi pripomoglo tudi k odpravljanju glavnih vzrokov nezakonitih migracij.

Slovenija pravkar prenavlja strateški in pravni okvir mednarodnega razvojnega sodelovanja, ki daje poudarek na partnerstvih, tudi z zasebnim sektorjem. V prihodnje bosta v vse vidike slovenskega razvojnega sodelovanja prednostno vključevani dve temi, to sta enakost spolov in varovanje okolja. Med slednje sodi tudi trajnostna energija, so slišali udeleženci konference v Ljubljani.

Na Evropski komisiji pojasnjujejo, da je trajnostna energija eno od ključnih področij, ki je praktično vpeto v vse zunanje instrumente EU.

➤ **Projekt CircEuit – z inovativnim načinom usposabljanja in multidisciplinarnim dostopom do krožnega gospodarstva**

Cilj evropskega projekta CircEuit je usposobiti 15 mladih raziskovalcev na področju krožnega gospodarstva. Evropska komisija ga navaja kot zgled tudi zaradi uporabe inovativnega programa za usposabljanje in interdisciplinarnega pristopa. V konzorciju sodeluje sedem akademskih institucij in dva partnerja iz zasebnega sektorja, ker je treba vzpostavljati partnerstva med akademskimi ustanovami in zasebnimi podjetji. Projekt bo trajal štiri leta, to je do avgusta 2020. EU ga financira s sredstvi iz programa Marie Skłodowska-Curie.

Področja, ki jih mladi raziskovalci raziskujejo, so poslovni modeli oziroma načini za spodbujanje krožne oskrbe, verige uporabnikov in dobavne verige, strategije oblikovanja, ki so potrebne v krožnem gospodarstvu, kakšni bodo makroekonomski učinki krožnega gospodarstva in katere sistemske spremembe so potrebne za njegovo vzpostavitev.

Partnerji v projektu načrtujejo, da bodo po zaključku imeli mrežo mladih dobro izobraženih in usposobljenih ljudi, ki bodo razumeli multidisciplinarno naravo krožnega gospodarstva. Tako bodo lahko na podlagi znanstvenih spoznanj krožno gospodarstvo prenesli v realno poslovno in družbeno okolje.

Konzorcij BRIGAID pomaga, da izbrane inovacije, ki jih razvijejo raziskovalci, majhna in srednja podjetja, zagonska podjetja, postanejo tehnično močnejše, bolj družbeno sprejemljive in bolj zanimive za vlagatelje.

Konzorcij BRIGAID ponuja mešanico metod in orodij za ocenjevanje, testiranje in izboljšanje inovacij, izda znak kakovosti, ki zagotavlja uresničljivost inovativnih rešitev. Podpira tudi razvoj poslovnih načrtov in ponuja priložnosti za mreženje z namenom okrepitev povezav med raziskovalci, inovatorji in končnimi porabniki.

Inovativna majhna in srednja podjetja ter zagonska podjetja s področja ustvarjalnosti in oblikovanja lahko do 24. oktobra svoje projekte prijavijo na razpis evropskega projekta WORTH, katerega ambasador je tudi Slovenski center za kreativnost. Izbrani projekti oziroma partnerstva bodo med drugim dobili podporo do 10 tisoč evrov, usposabljanje in svetovanje, sodelovanje na dveh mednarodnih dogodkih, mreženje in čezsektorsko sodelovanje. Vključevati morajo dva ali tri partnerje iz različnih področij iz vsaj dveh držav.

Področja, ki pridejo v poštev, so med drugimi pohištvo, tekstil, obutev, usnje, nakit, dodatki. Partnerstva, ki jih izberejo, so običajno sestavljena bodisi iz oblikovalcev (samozaposlenih, laboratorijev za oblikovanje in zagonskih podjetij), izdelovalcev (obrtnikov in proizvodnih majhnih in srednjih podjetij) in tehnoloških podjetij (inovatorjev, tehnoloških laboratorijev, ponudnikov tehnologij in zagonskih podjetij). Partnerstvo WORTH bo v štirih letih oblikovalo in podprlo 150 partnerstev. S prvim razpisom, ki se je zaključil decembra 2017, je med več kot 100 prijavami izbral 25 partnerstev. ➤ **TURAS je zgledni projekt za pretvorbo stresnih urbanih območij v za življenje prijazna in trajnostna območja**

Članica SBRA Univerza v Ljubljani in Regionalna Razvojna Agencija Ljubljanske Urbane Regije sta bili med dvajsetimi partnerji evropskega projekta TURAS, ki ga Evropska komisija predstavlja kot zgled za pretvorbo urbanih območij, kjer je veliko stresa, v za življenje bolj prijazna in trajnostna območja, kjer lokalne skupnosti lahko zacvetijo. Partnerji v projektu so razvili koncept »zelena dnevna soba«. Na vrhu parkirne hiše v nemškem mestu Ludwigsburg so jo odprli aprila 2014.

Na 140 kvadratnih metrih je 7000 grmov in 128 platan, pod katerimi ljudje lahko sedijo in se srečujejo v senci. Mobilno različico »zelene dnevne sobe« v velikosti zabojnika je mogoče s tovornjakom prepeljati v katero koli ulico v mestu.

Partnerji v projektu so izvedli tudi druge naravne rešitve, ki vključujejo lokalne skupnosti v partnerskih mestih med katerimi je tudi Ljubljana. Ti koncepti vključujejo različna področja, kot so zelene površine, zapuščena urbana območja, krožno gospodarstvo, ekosistemski storitve, onesnaževanje zraka in hrup, trajnostne stavbe, prilagajanje podnebnim spremembam, biotsko raznovrstnost, energetsko učinkovitost, ukrepanje v primeru poplav in urbano kmetijstvo.

Rezultat projekta TURAS je tudi ustanovitev podjetja Osmos, ki nadaljuje z izvedbo pobud, ki so jih razvili partnerji v projektu. Osmos želi pomagati lokalnim skupnostim, da razvijejo trajnostno urbano gospodarstvo.
