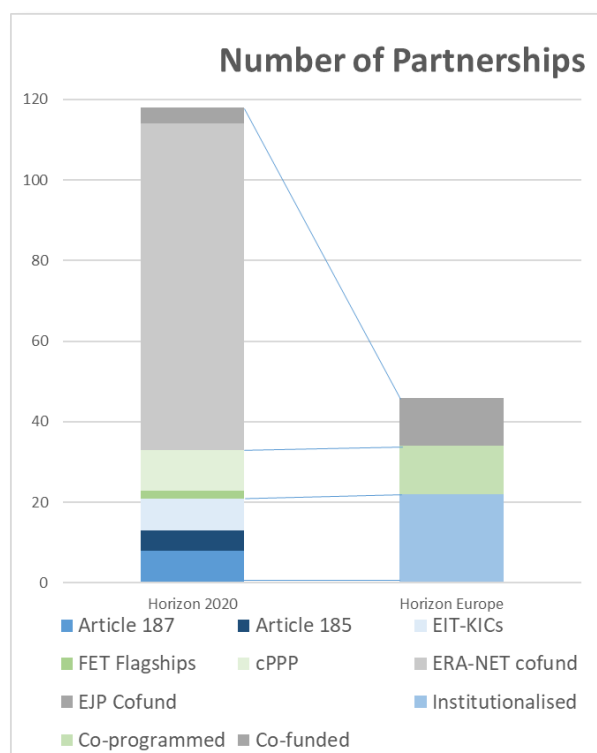

Evropska komisija je sprejela nova pravila za varno upravljanje z droni v EU. Od leta 2020 se bodo operaterji dronov morali registrirati pri nacionalnih organih. Države članice bodo lahko določile tako imenovana območja prepovedi letenja za drone, katerih lokacija bo satelitsko opredeljena. Takšna območja bodo lahko zajemala letališča ali mestna središča. Registracija operaterjev, možnost identifikacije na daljavo in določitev geografskih območij naj bi nacionalnim organom omogočale boljše preprečevanje zlorab ali nezakonitih aktivnosti z droni. Člani lahko podrobnejše informacije dobijo na SBRA.

Pravila za varno upravljanje z droni v EU dopolnjujejo tehnične zahteve za drone, ki jih je Evropska komisija sprejela marca. Veljala bodo tako za vse uporabnike vključno s tistimi, za katere je uporaba dronov pristožna dejavnost. Enotna evropska pravila bodo nadomestila pravila, ki so jih države članice sprejela na nacionalni ravni. Evropska komisija ocenjuje, da bo večina dronov, za katere bodo veljala nova pravila, množično proizvedeni droni, ki so na voljo na trgu. Zanje bodo veljale le osnovne zahteve, kot sta registracija in elektronska identifikacija.

Evropska komisija napoveduje, da bo skupaj z Evropsko agencijo za varnost v letalstvu (EASA) objavila smernice in tako imenovane »standardne scenarije« za upravljavce dronov kot pomoč upravljavcem pri implementaciji novih pravil.

Univerza v Ljubljani med koordinatorji projektov sklada Marie Skłodowske-Curie

Člana SBRA Inštitut Jožef Stefan in Univerza v Ljubljani sta med koordinatorji projektov za katere bo Evropska komisija iz sklada Marie Skłodowske-Curie namenila 470 milijonov evrov za 1.800 doktorskih kandidatov. Podprla bo 128 inovativnih izobraževalnih mrež, ki združujejo 1.389 organizacij v 56 državah. Projekti bodo prejemnikom omogočili vrhunske raziskave in usposabljanje v mnogih državah sveta. Inštitut Jožef Stefan bo koordiniral projekt GMOS-Train za katerega bo na voljo nekaj manj štiri milijone evrov, Univerza v Ljubljani pa projekt GreenTRIBOS, ki je vreden okrog 3,2 milijona evrov.

Med 128 izbranimi doktorskimi programi je 16 evropskih doktorskih programov s področja industrije, v katere so neakademske organizacije vključene enako kot univerze, ter 9 skupnih doktorskih programov evropskih univerz. Izbrani projekti zajemajo številna področja raziskav, od inženirstva in komunikacije do okolja, zdravja in paleontologije. Sporazumi o dodelitvi sredstev bodo podpisani 15. avgusta za obdobje štirih let.

Projekt "Global Mercury Observing System for the Implementation of Minamata Convention" (GMOS-Train), katerega koordinator bo Inštitut Jožef Stefan, vključuje 11 evropskih partnerjev. V njem sodelujejo ugledne raziskovalne institucije, kot sta Univerza Harvard in MIT, organizacije, kot sta UN Environment in JRC Ispra, ter ugledne nevladne organizacije.
