Modeli 3D tumorjev, ki jih razvijajo raziskovalci v okviru projekta FORECAST, so narejeni iz biomaterialov v kombinaciji z različnimi zdravimi in rakavimi celicami. Predstavljajo različne stopnje raka od nastanka tumorja do širitve metastaz na različne organe. Cilj raziskovalcev je najti rešitev, ki bo omogočila odkritje in začetek zdravljenja raka v zelo zgodnji fazi.
