Obvestilo Evropske komisije upravičencem in koordinatorjem Obzorje 2020 projektov

Komisija se v celoti zaveda, da lahko izbruh virusa Corone v EU in drugod vpliva na izvajanje tekočih projektov Obzorja 2020. Na primer, trenutna situacija lahko upravičencem prepreči izpolnjevanje svojih obveznosti v okviru projekta ali opravljanja dela na območju, ki ga je prizadel virus. Upravičenci lahko tudi odpovejo sestanke zaradi nerazpoložljivosti ključnega osebja ali ker se večina udeležencev ne more udeležiti.

Člen 51 Vzorčnega sporazuma o dodelitvi sredstev H2020 – Grant agreement (GA) (H2020 MGA) določa splošni okvir in pogoje, v katerih je mogoče uporabiti klavzulo o višji sili. Splošno pravilo v skladu s H2020 bo v primeru višje sile stranko oprostilo izpolnjevanja svojih obveznosti (tj. To ne bo kršitev obveznosti iz GA in noben od škodljivih ukrepov za kršitev ne bo uporabljen). Stroški bodo upravičeni, če izpolnjujejo splošne pogoje za upravičenost, kot velja za vse druge stroške, nastale v okviru ukrepa. Če pa višja sila povzroči dodatne stroške za izvedbo ukrepa, jih bo običajno nosil upravičenec.

Če pride do take situacije, morajo upravičenci takoj obvestiti Komisijo ali agencijo, ki bo za vsak primer posebej preučila morebitno uporabo pravil o višji sili v smislu člena 51 MGA H2020.

Primer: Upravičenci se ne morejo udeležiti sestankov ali dogodkov, povezanih z ukrepanjem, zaradi nedavnega stika z nekom, ki trpi zaradi virusa, ali zaradi svoje prisotnosti na območju, za katerega velja, da je ogroženo. Stroški potovanja ali nastanitve, ki jih ni bilo mogoče odpovedati in jih ne povrnejo iz drugih virov, bi bili upravičeni (pod pogojem, da je izpolnjen pogoj za upravičenost do stroškov).

Will the deadlines for Horizon 2020 calls be extended related to the COVID-19 outbreak?

The recent escalation of restrictions related to the COVID-19 outbreak may hamper applicants' ability to prepare and finalise high-quality proposals. For this reason, for **Horizon 2020 calls with original deadlines between now and 15 April, extensions will be applied**. The precise new deadlines for each call and topic will be published on the call and topic pages on the Funding and Tenders Portal.

For the following two calls, no extension of deadline/cutoff date will apply:

EIC-SMEInst-2018-2020

In all cases, potential applicants are advised to prepare themselves as necessary, especially by establishing effective communication links for remote collaborative work, also anticipating possible further restrictions in the coming weeks.

V novem načrtu je prav tako predvideno, da bodo potrošniki imeli dostop do zanesljivih informacij o vprašanjih, kot sta popravlјivost in trajnost izdelkov, da bi lahko na njihovi osnovi lažje sprejemali okoljsko trajnostne odločitve. Potrošniki naj bi lahko uveljavljali pravico do popravila.

Kot sektorji, ki uporabljajo največ virov in kjer so možnosti za krožnost velike, so v akcijskem načrtu navedeni elektronika in IKT, baterije in vozila, embalaža, plastika, tekstilni izdelki, gradbeništvo, stavbe in hrana.

Evropska komisija bo 107 inovativnim evropskim projektom v okviru Evropskega sveta za inovacije (EIC) namenila 344 milijonov evrov za lažje uveljavljanje idej na trgu. Med izbranimi projekti je 63 v fazi raziskav, namenjenih jim bo 162 milijonov evrov. Zagonski ter inovativnim majhnim in srednjim podjetjem bo v okviru preostalih 44 projektov namenjeno 182 milijonov evrov za njihov zagon oziroma spodbujanje njihove inovativnosti. Ta podjetja bodo imela tudi možnost svetovanja in poslovnih pospeševalnih storitev.

Inovativna podjetja lahko že drugo leto zapored poleg podpore z nepovratnimi sredstvi zaprosijo tudi za kombinacijo nepovratnih sredstev in naložb zasebnega kapitala. Evropska komisija prek javnega razpisa zbira prijave kandidatov za vodjo programa za razvoj prelomnih tehnologij na področju energije in okolja, ki bodo ključne za uresničitev Evropskega zelenega dogovora.

Evropski svet za inovacije podpira inovatorje, podjetnike, mala podjetja in znanstvenike, ki se želijo z izjemnimi zamislimi uveljaviti na mednarodni ravni. Trenutno je v pilotni fazi, v celoti pa bo deloval od leta 2021 v okviru naslednjega programa EU za raziskave in inovacije Obzorje Evropa.
