Opis:	<p>The European Space Agency invites applications for its gravity-related research summer school grants, under the ESA academy programme. These enable university students to attend a four-and-a-half day gravity-related research summer school, to be held from 22 to 26 June 2020 in Transinne, Belgium. The summer school offers an overview of the current research under microgravity and hypergravity conditions in life and physical sciences and explains the interest and benefits of performing research at different gravity levels. Students will attend lectures and work within small groups to devise ideas for prospective experiments.</p> <p>Master's students who are citizens of an ESA member state, Canada or Slovenia and enrolled in a university studying an engineering or scientific subject may apply. Applicants must be aged between 18 and 32 and have never taken part in any gravity-related activity and have never been sponsored by ESA's education office or the European low gravity research association.</p> <p>Grants cover accommodation, meals and up to €200 for travel costs. There are 30 grants available.</p>

All other call details remain unchanged.</p> <p>The Directorate-General for Employment, Social Affairs and Inclusion invites proposals for its call on incubators for inclusive and social entrepreneurship, under its programme for employment and social innovation (EaSI). This supports existing networks of mainstream business incubators to expand their outreach to inclusive and social entrepreneurship. Actions should draw from the experience of support organisations and networks already targeting social entrepreneurs and potential entrepreneurs from underrepresented groups. Types of activities may be:</p>

Applicants must be public or private entities of any type and must be a established formal network of business incubators with its own legal personality or representing an established formal network. The applicant must have members established in at least 14 EU member states and in at least one non-EU EaSI participating country.</p> <p>The total budget is worth €1.3 million. One grant, worth between €1m and €1.3m over 24 months, is available.</p>

Opis:	<p>Applicants submit multi-annual proposals for new or existing doctoral programmes or fellowship programmes which are expected to have an impact on enhancing research- and innovation related human resources on regional, national or international level.</p> <p>Applicants having benefited from COFUND under previous calls (under the Seventh Framework Programme or under Horizon 2020) must explain how their proposal adds value in relation to the excellence and/or the impact award criteria, compared to their previous grant(s). As an example, added value could take the form of increased networking with organisations in less represented countries or capacity building measures there to further structure the European Research Area.</p> <p>Researchers supported under this scheme shall comply with the mobility rules of the Marie Skłodowska-Curie actions.</p> <p>Limitations regarding the researchers' origin and destination should be avoided. Support cannot be awarded to researchers who are already permanently employed by the organisation hosting them.</p> <p>Proposed programmes are encouraged to cover all research disciplines ("bottom-up"), but can also focus on specific disciplines. In this case the range of covered disciplines should allow reasonable flexibility for the researchers.</p> <p>Programmes that prioritise specific research disciplines based on national or regional Research and Innovation Strategies for Smart Specialisation (RIS3</p>

It is based on an application made jointly by the researcher and the beneficiary in the academic or non-academic sectors.</p> <p>Only one proposal per individual researcher per call will be evaluated.</p> <p>Fellowships take the form of European Fellowships or Global Fellowships. European Fellowships are held in EU Member States or Horizon 2020 Associated Countries and are open to researchers either coming to Europe from any country in the world or moving within Europe. The researcher must comply with the rules of mobility in the country where the European Fellowship is held.</p> <p>Direct return to and long-term reintegration of researchers in Europe, including in their country of origin, is supported via a separate multi-disciplinary reintegration panel of the European Fellowships. For the reintegration panel, there must be direct mobility to the country of the beneficiary in Europe from a third country (compulsory national service and/or short stays such as holidays are not taken into account).</p> <p>Support to individuals to resume research in Europe after a career break, e.g. after parental leave or due to recent migration, is ensured via a separate multi-disciplinary career restart panel of the European Fellowships. To qualify for the career restart panel, researchers must not have been active in research for a continuous period of at least 12 months within the 18 months immediately prior to the deadline for submission.</p> <p>Researchers seeking to work on research and innovation projects in an organisation from the non-academic sector will be supported via a separate multi-disciplinary society and enterprise panel of the European Fellowships. The objective of this panel is to facilitate career moves between the academic and non-</p>

academic sectors, to stimulate innovation, and to open attractive career opportunities for researchers outside academia.

Under this umbrella, the HDHL-INTIMIC partners are now launching a new joint transnational call called “Prevention of unhealthy weight gain and obesity during crucial phases throughout the lifespan (PREPHOBES)”.</p> <p>This new call intends to fund dedicated, top-class transnational research consortia to provide insights in innovative strategies to prevent or reduce overweight and obesity in defined target populations based on certain life stages. This call gives a unique opportunity to connect researchers with expertise in obesity prevention and stakeholders that can facilitate policy-based solutions.</p> <p>Eleven funding agencies from 10 different countries (Austria, Belgium, Czech Republic, France, Germany, Ireland, Italy, Latvia, Spain, The Netherlands) have already committed a budget of more than 7M €.</p> <p>Aims of the call</p> <p>The aim of this call is to support research projects that focus on the development, implementation and evaluation of innovative strategies designed to prevent or reduce overweight and obesity, in defined target populations based on certain life stages.</p> <p>The research to be funded within this call should have a holistic, multi-disciplinary and solution orientated approach and focus on one or more crucial phase(s) throughout the lifespan such as transition periods (for example from prenatal to postnatal phase/infancy, pre-school to school age, adolescence to early adulthood) or critical life events (for example moving, marriage, period in between pregnancies, diagnosis of a chronic disease, recovering from disease, retirement, migration). To increase the impact of the research and facilitate its later use in future policies on lifestyle interventions and public health, this call</p>

	strongly encourages the active integration of stakeholders (e.g. patient and/or consumer organisations) or citizen science approaches. These partners should be engaged in the research process from conception of the study to dissemination and implementation.

Call for collaboration for access to screening facilities for rationally selected compounds against SARS-CoV-2

Opis:	<p>Exscalate4CoV (acronym E4C) is an EU-funded project that was selected after the emergency Call of expression of interest that the European Commission (DG RTD) issued on 31 January. The project will receive a 3 million EUR of EU funding in the next 18 months. It is consisting of a coalition of three of the most powerful supercomputing centres in the EU (CINECA in Italy, Barcelona supercomputing centre in Spain and Jülich supercomputing centre in Germany) together with a pharmaceutical company and several large Institutes dealing with biology and bio-molecular dynamics. The E4C team use supercomputers in the search of a therapies (small molecule drugs) against SARS-CoV-2 by complementing the classical trial and error clinical approach and possible experimentation in patients, by comparing the signature of the protein of the virus against active molecules that are used in existing databases of compounds. The project is currently processing digital models of the protein of the virus and is matching them against a publicly available database of thousands of known active antimolecules that are part of existing drugs with the aim to find out which combinations of active molecules could react to the virus.</p> <p>The E4C project is also establishing a pipeline of phenotypic and target based screens to evaluate the efficacy of repurposed, commercial and de-novo designed compounds.</p> <p>To supplement the E4C compound pipeline, we invite organisations to submit proposals for screening of their compounds for efficacy profiling on the E4C Biology platforms.</p> <p>These may include compounds identified from in-silico screening of SARS CoV2 associated targets or rationally selected repurposed compounds and bioactives. Incoming compounds will be tested in phenotypic assays and functional biochemical assays against E4C's priority viral encoded targets, (RNA-directed RNA polymerase; 3C-like proteinase; Papain-like proteinase; Guanine-N7 methyltransferase and 2'-O-methyltransferase). Attractive compounds may then be subject to Mechanism of Action, studies including structural biology assessment by X-ray and Cryo-EM.</p> <p>The minimum requirements for providing physical compounds are: i) rational reason for selection; ii) a positive review by E4C medicinal chemists; iii)</p>

	<p>compounds have not already been analysed in E4C or reported assays; iv) physical material is available (10mM in 100% DMSO, 20 microliters volume).</p> <p>Submitters should have access to material for follow up studies or medicinal chemistry resources for synthesis of additional material. Full criteria and conditions are defined in the "Drug-Box" submission portal on the E4C website – www.exscalate4cov.eu.</p>



Evropska komisija je objavila nasvete za izvajanje smernic glede upravljanja meja, s katerimi želi zagotoviti pretok tovora po Evropski uniji v času sedanje pandemije. Državam članicam je naročila, da morajo vse ustrezne mednarodne mejne prehode znotraj vseevropskega prometnega omrežja (TEN-T) nemudoma razglasiti za mejne prehode z »zelenimi voznimi pasovi«. Prehod meje, vključno s preverjanji in zdravstvenimi pregledi, ne bi smel trajati več kot 15 minut. Člani lahko dodatne informacije dobijo na SBRA.

Mejni prehodi z zelenimi voznimi pasovi bi morali biti odprti za vsa tovorna vozila ne glede na to, kakšno blago prevažajo. Postopke bi bilo treba čim bolj skrajšati in omejiti na to, kar je nujno potrebno. Preverjanja in preglede bi bilo treba izvajati, ne da bi morali vozniki pri tem zapustiti svoja vozila. Od voznikov tovornih vozil pristojni organi držav članic zahtevati, da bi morali poleg osebnega dokumenta

in vozniškega dovoljenja ter po potrebi dopisa delodajalca predložiti še druge dokumente. Dovoljena bi morala biti elektronska predložitev oziroma elektronski prikaz dokumentov.

Evropska komisija je države članice tudi pozvala, naj glede na trenutne razmere začasno opustijo vse omejitve dostopa v cestnem prometu, ki trenutno veljajo na njihovem ozemlju, kot so prepovedi vožnje ob koncu tedna in ponoči ter sektorske prepovedi.
