### 1) Description of the Project

## A. Description of the EU4Dialogue Programme

In the Eastern Partnership region, five of six countries are affected by conflicts: Armenia and Azerbaijan (over Nagorno-Karabakh), Georgia (Abkhazia and South Ossetia), the Republic of Moldova (Transnistria) and Ukraine (Crimea and Donbass). This action covers all the unresolved conflicts except the one affecting Ukraine. All these conflicts remain unresolved and, in some cases, continue to produce casualties.

Further efforts are therefore needed to move from the current *status quo* towards conflict resolution, and it is crucial that the populations across the conflict divides are engaged. Such engagement, in areas of common interest, can help create trust, change perceptions, improve conditions and help conflict transformation and diplomatic efforts towards conflict resolution.

The overall objective of this action is to contribute to the transformation of the unresolved conflicts in the EaP region. The three components will focus on:

- i) establishing an environment that can help defuse tension and foster better understanding across the conflict divides;
- ii) improving targeted sectors, including human security, for communities; and
- iii) improving exchanges across the divide through education and culture.

The overall duration of the programme is foreseen to last 48 months (2020-2024).

# B. Description of the proposed project on improved exchange (regional, intra-regional and/or with the EU) through education and culture as means of conflict transformation

The European Commission wishes to work on this component of the overall programme through a consortium of Member States agencies <u>specialised in the external cooperation in the fields of education and culture</u> (for example Goethe Institute, DAAD, Alliance Francaise, Società Dante Alighieri, etc.<sup>1</sup>). In case advisable, and due to the political sensitivity of the topic, the consortium can include or partner with appropriate NGOs to facilitate access to the conflict-affected communities. The experience that Member States agencies gained in implementing Erasmus+ and their own educational and cultural cooperation is seen as an asset for the implementation of the project in the EU Eastern neighbouring countries. The total amount of the EU contribution for this component is EUR 3.000.000, and co-financing – even limited – is expected from the participating Member State agency(ies) and/or from the beneficiary (to be provided along the planned 4 years of implementation). The agreement will be concluded either as a Delegation Agreement or in the form of a standard EU External Actions grant contract.

- 4. If contacts have been established with partners already, please mention who these partners would be, their statute and contribution to the project. Describe briefly the rationale of the partnership.
- 5. If proposed by the contracting authority (European Commission services DG NEAR), would your organisation be ready/have the experience to consider teaming up with other European partners?
- 6. Confirmation that your organisation is prepared to implement communication actions on this project to strengthen EU visibility and branding in close coordination with DG NEAR.
