Delovati je začel Evropski sklad za socialne inovacije in učinek (ESIIF). Jamstvo zanj bo zagotovljeno s programom EU za zaposlovanje in socialne inovacije (EaSI), upravljal pa ga bo Evropski investicijski sklad (EIF). Cilj sklada je prek povezovanja vlagateljev s socialnimi podjetji zapolniti vrzel v financiranju, s katero se socialna podjetja pogosto srečujejo. Financiranje iz sklada naj bi koristilo socialnim podjetnikom, ki se osredotočajo na reševanje perečih problemov na področjih, kot so izobraževanje, hrana, zdravstvo in socialne storitve. 
Objavljeni so posodobljeni načrti dela za evropske prometne koridorje omrežja TEN-T

This aims to bring together cluster organisations and other business network organisations from EU member states or countries participating in the EU's Competitiveness of Enterprises and Small and Medium-sized Enterprises (COSME) programme interested in teaming up in European Strategic Cluster Partnerships. This aims to strengthen cluster management excellence and facilitate exchanges and strategic partnering between clusters and specialised ecosystems and cities across Europe, including through implementation of the ClusterXchange mobility scheme.</p> <p>Applicants must be legal entities based in EU member states or countries participating in the COSME programme. They may be for-profit or non-profit legal entities as well as fully or partly public or private bodies. Consortia must be composed of at least three different legal entities which are established in a minimum of three different EU member states or other countries participating in the COSME programme, and include at least one consortium member representing an organisation established in a region classified as less developed or in transition according to the mapping proposed for structural funds eligibility for the period 2014-2020.
